1. Apologies

2. Declaration of pecuniary/non-pecuniary interest regarding items on the agenda.

4. Matters arising

Bottles Rise Lane/Behind Village Hall/ Riston Lane – Police notified, have visited the area, items found to the rear of the village hall cleared, police will keep a regular eye on the area for further evidence of activities. Clerk has spoken to Cllr Holtby to see if ERYC can do anything, Cllr Holtby passed to Anti-social behaviour team. Long Riston also seeing increases in similar issues. Possible reasons for the increase in this type of rubbish discussed.

Clerk to request pickers, gloves etc from ERYC. Collection of rubbish can be arranged.

Still no update re speed survey results, however e mail received from traffic management to say where scores greater than 15 are recorded, the policy is to request an engineering review. If they come back with no engineering plan, safer roads Humber will look at its mobile camera enforcement activities, the full report is still not available. Clerk wrote for clarification Catwick scored greater than 15 which is correct.
